### **Hours of Operation**

The campus has classes in session Monday through Friday between 8:00 a.m. and 1:45 p.m. Evening classes are offered Monday through Thursday between 3:55 p.m. and 8:00 p.m. to serve the needs of post-secondary and adult general education students.



The D.A. Dorsey Technical College is a public educational facility governed by Miami-Dade County Public Schools System in Miami, Florida. The main campus of D.A. Dorsey Technical College is a 5,344 square ft, block one-story building comprised of five offices for administrative and support staff, 19 classrooms with industry-specific lab facilities. The building contains a conference room and 4 public restroom facilities. It is located approximately two miles from US 119, which connects Boone County to Lincoln and Logan counties.

D.A. Dorsey Technical College is the only main campus and is located 1.4 miles from the nearest 911 center, 6 miles from the Miami Dade Fire Rescue Firehouse 2, and 3 miles from The City of Miami – North District Substation. The nearest hospital is North Shore Medical Center which is 2.2 miles away.

### **Scope and Availability**

Reporting and Investing Accident in the Automated Incident Reporting System (AIRS)

Through our Automated Incident Reporting System (AIRS) we are required to investigate and document any accidents or incidents. The form includes the reporting of the victim and/or offender contact information, the demographics of the incident, the category of the incident, the local health safety agency contact information, and the description.

Faculty/staff and students are orientated on reporting accidents or incidents to administration immediately. Once reported, the AIRS report is executed. Faculty/staff are made aware of the procedures at the opening of school's meeting and students are made aware via the orientation process.

All non-confidential reports are communicated to help in the prevention of any future accidents or incidents.

Reporting Procedures:

\*Call 911 immediately if warranted.

- 1. Report all incidents and or accidents to the on-site administrator immediately.
- 2. All witnesses to the incident and or accident are required to write a statement.
- 3. The on-site administrator must report the incident and or accident in the AIRS and submit it to the district for further processing.

#### SCHOOL-SPECIFIC INSTRUCTIONS FOR DRILLS:

#### FIRE DRILL:

When the fire alarm is activated, all occupants in the building must exit to their closest exit. Mr. Marcus L. Miller (principal) and Mr. Jacoby Watkins (assistant principal) are in constant contact using two-way radios as they make sure the building is evacuated. All occupants must have face covering during drills. All occupants are to move away from the building and teachers must gather their students for attendance to make sure all are accounted for. All occupants may enter the building after "All Clear" is given by the administration.

#### **BOMB THREAT:**

When a bomb threat occurs, all occupants leave the building at the closest exit. Mr. Marcus L. Miller (principal) and Mr. Jacoby Watkins (assistant principal) will communicate by radio as well as contacting the Miami-Dade County Public Schools Police Department. All occupants will move away from the school and teachers will take attendance to make sure all students are accounted for. Staff will re-enter when an "All Clear" has been given.

#### SHELTER IN PLACE:

School administrator will announce "Code Yellow" lockdown for all occupants shall shelter in place. Staff, students, and occupants in open areas should immediately report to the nearest secured area. Teachers and students are to lock all doors, close all windows including shades and use "hard corners". Audio-visual equipment will be turned off. Disregard the bell system. Teachers should take attendance to make sure all students are accounted for. Follow the directions of emergency personnel and school administrators. Once an "All Clear" is given, teachers and students may resume normal school operations.

#### PRECAUTIONARY LOCKDOWN:

School administrator will announce "Code Yellow" lockdown for all occupants shall shelter in place. Staff, students, and occupants in open areas should immediately report to the nearest secured area. Teachers and students are to lock all doors, close all windows including shades and use "hard corners". Audiovisual equipment will be turned off. Disregard the bell system. Teachers should take attendance to make sure all students are accounted for. Follow the directions of emergency personnel and school administrators. Once an "All Clear" is given, teachers and students may resume normal school operation.

#### LOCKDOWN:

Our "Code Red" procedures are lights out, classroom doors and windows are closed and locked. Windows with blinds and shades must be pulled down for covering. Door vision panels must always remain covered. Audiovisual equipment will be turned off and the bell system deactivated. Staff and students shall move to designated hard corners away from windows, doors, and glass. Everyone should take cover and remain calm until an "All Clear" announcement is made. Once an "All Clear" is given, teachers and students may resume normal school operation.
